### Who We Are

**Controlaccount Ltd**, ('Controlaccount' or 'we' or 'us' or 'our') gather and process your personal information in accordance with this privacy notice and in compliance with the General Data Protection Regulation and relevant UK data protection Regulation and laws. This notice provides you with the necessary information regarding your rights and our obligations, and explains how, why, and when we process your personal data.

Controlaccount is a debt collection agency providing credit management solutions to businesses. Our registered office is at Compass House, Waterside, Hanbury Road, Bromsgrove, Worcestershire B60 4FD and we are a company registered in England and Wales under company number 02765607. We are registered on the Information Commissioner's Office Register; registration number **Z6855987**, and act as the data controller/data processor when processing your data. Controlaccount is committed to safeguarding and preserving your privacy during the course of our dealings with you in the provision of our services. In our communications to you electronically or in general and if you visit us through our website. This Privacy Policy, together with our Terms and Conditions, provides an explanation as to what happens to any personal data that you provide to us, or that we collect from you. ### **INFORMATION THAT WE COLLECT**

## Subject Creditors

Controlaccount receives and processes data from its Clients for the legitimate purpose of recovering monies owed to them. When relying on a 'legitimate interest' for processing data, we have the extra responsibility for considering and protecting people's rights and interests. Prior to receiving data from a Client, Controlaccount will carry out a 'legitimate interest' test which takes into consideration the following principles: -

The importance of carrying out a 'legitimate interests' test is so that we can:-

- identify a legitimate interest;
- show that processing is necessary to achieve it; and
- balance it against the individual's interests rights and freedoms.

By following these principles, we are confident that an individual's interests do not override those legitimate interests.

## Our Website

In operating our website we may collect and process the following data about you:

- Details of your visits to our website and the resources that you access, including, but not limited to, traffic data, location data, weblogs, and other communication data;
- Information that you provide by filling in forms on our website, such as when you registered for information or make a purchase, including Name, Address, Email Address and Telephone Number;
- Information provided to us when you communicate with us for any reason.

Cookie	Time from set/update	Purpose
__utma	2 years from set/update	Used to distinguish users and sessions. The cookie is created when the javascript library executes and no existing __utma cookies exists. The cookie is updated every time data is sent to Google Analytics.
__utmt	10 minutes	Used to throttle request rate.
__utmb	30 mins from set/update	Used to determine new sessions/visits. The cookie is created when the javascript library executes and no existing __utmb cookies exists. The cookie is updated every time data is sent to Google Analytics.
__utmc	End of browser session	Not used in ga.js. Set for interoperability with urchin.js. Historically, this cookie operated in conjunction with the __utmb cookie to determine whether the user was in a new session/visit.
__utmz	6 months from set/update	Stores the traffic source or campaign that explains how the user reached your site. The cookie is created when the javascript library executes and is updated every time data is sent to Google Analytics.
__utmv	2 years from set/update	Used to store visitor-level custom variable data. This cookie is created when a developer uses the _setCustomVar method with a visitor level custom variable. This cookie was also used for the deprecated _setVar method. The cookie is updated every time data is sent to Google Analytics.
_ga	2 years	Used to distinguish users.
_gat	10 minutes	Used to throttle request rate.

Cookie	Time from set/update	Purpose
_hjUserId	365 days	Hotjar cookie. This cookie is set as soon as a user loads a page which contains the Hotjar code. The cookie contains a universally unique identifier (UUID) which allows Hotjar to track the same visitor across multiple pages and sessions.
_hjIncludedInSample	End of browser session	Hotjar cookie. This session cookie is set to let Hotjar know whether that visitor is included in the sample which is used to generate funnels.
JSESSIONID	End of browser session	Hotjar cookie. Used to monitor session counts for an application.
session	End of browser session	Hotjar cookie. Keeps your website session alive.
uid2	30 days	This cookie contains a unique randomly-generated value that enables the distinction between browsers and devices. It is matched against information – such as advertising interest segments and histories of ads shown in the browser or device.
uuid2	Indefinite	When a user opts out of having the platform used to select ads based on online behaviour, the unique value in uuid2 is deleted and replaced with the non-unique value “-1”.

To the extent that any of the cookies described above collect personal information about a user of our website that personal information will be handled in accordance with our Privacy Policy.

Such information will not identify you personally it is statistical data about our visitors and their use of our site. This statistical data does not identify any personal details whatsoever.

Similarly, to the above, we may gather information about your general internet use by using a cookie file. Where used, these cookies are downloaded to your computer automatically. This cookie file is stored on the hard drive of your computer as cookies contain information that is transferred to your computer's hard drive, and they help us to improve our website and the service that we provide to you. All computers have the ability to decline cookies, this can be done by activating the setting on your browser which enables you to decline the cookies. Please note that should you choose to decline cookies, you may be unable to access particular parts of our website. Our advertisers may also use cookies, over which we have no control. Such cookies (if used) would be downloaded once you click on advertisements on our website.

## **HOW WE WILL USE YOUR INFORMATION**

The information that we collect and store relating to you is primarily used to enable us to provide and deliver our services to you. In addition, we may use the information for the following purposes:

- To provide you with information requested from us, relating to our products or services
- For the purpose of processing data on a 'legitimate interests' basis
- To provide information on other products which we feel may be of interest to you, where you have consented to receive such information
- To meet our contractual commitments to you
- To notify you about any changes to our website, such as improvements or service/product changes, that may affect our service.
- If you are an existing customer, we may contact you with information about services similar to, or which may be useful to you.

Further, we may use your data, or permit selected third parties to use your data, so that you can be provided with information about unrelated goods and services which we consider may be of interest to you. We or they may contact you about these goods and services by any of the methods that you consented at the time your information was collected.

If you are a new customer, we will only contact you or allow third parties to contact you only when you have provided consent and only by those means you provided consent for. If you do not want us to use your data for our or third parties you will have the opportunity to withhold your consent to this when you provide your details to us on the form on which we collect your data. Please be advised that we do

not reveal information about identifiable individuals to our advertisers, but we may, on occasion, provide them with aggregate statistical information about our visitors.

## **STORING YOUR PERSONAL DATA**

We may transfer data that we collect from you to locations outside of the European Economic Area for processing and storing. Also, it may be processed by staff operating outside the European Economic Area who work for us or for one of our suppliers. For example, such staff maybe engaged in the processing and concluding of your order, the processing of your payment details and the provision of support services. In the event that any information is to be stored on servers which are hosted in non-EU countries, where this is the case, we will take steps to ensure that those providers use the necessary level of protection for your information and abide by the strict agreements and measures set out by Controlaccount Ltd to protect your data and comply with the relevant data protection laws and Regulations. By submitting your personal data, you agree to this transfer, storing or processing. We will take all reasonable steps to make sure that your data is treated securely and in agreement with this Privacy Policy. Data that is provided to us is stored on our secure servers. Details relating to any transactions entered into on our site will be encrypted to ensure its safety. The transmission of information via the internet is not completely secure and therefore we cannot guarantee the security of data sent to us electronically and transmission of such data is therefore entirely at your own risk. In circumstances where we have given you (or where you have chosen) a password so that you can access certain parts of our site, you are responsible for keeping this password confidential.

## **DISCLOSING YOUR INFORMATION**

Where applicable, we may disclose your personal information to any member of our group. This includes, where applicable, our subsidiaries, our holding company, and its other subsidiaries (if any). We may also disclose your personal information to third parties where it is legal and necessary to do so and in circumstances where there is a lawful basis for processing such as: -

- Where we sell any or all of our business and/or our assets to a third party;
- Where we are legally required to disclose your information in compliance with our legal obligations.
- To assist fraud protection and minimise credit risk;
- Data relating to a criminal offence and for the purposes of civil law enforcement;
- Legal claims where the processing is necessary for the establishment exercise or defence of legal claims, or for Courts acting in their judicial capacity.

A controller may process personal data where the controller has a legal obligation to perform such processing. The principle which applies in these circumstances is that the legal obligation must apply to the controller and must be binding in nature. For example, the "compliance with legal obligations" lawful basis does not apply where a government authority requests access to personal data, but the controller's compliance with that request is not legally mandatory. There may be other lawful bases available to the controller, depending on the facts.

### HOW LONG WE KEEP YOUR DATA

We take seriously our responsibilities in relation to data handling and storage. **We will only ever retain personal information necessary in relation to the purpose for which the data is processed.** We have in place a retention document policy providing for erasure, pseudonymisation and encryption of data and which remains under review to ensure we meet these obligations.

We are required under UK tax law in some circumstances to keep and maintain accounting records for 6 years after which the data will be destroyed.

Where you have consented to us using your details for direct marketing purposes, we will keep such data until you notify us otherwise and/or withdraw your consent.

### SPECIAL CATEGORIES DATA

Owing to the products and services that we offer, Controlaccount sometimes needs to process sensitive personal information (known as special category data) about you in circumstances where it may be required in the interests of justice and/or for any other legal purpose. Where we collect such information, we will only request and process the minimum necessary for the specified purpose and identify a compliant legal basis for doing so.
